Victoria Road, Kirkcaldy

BACKGROUND

This project is an off the shelf acquisition being developed by James Property Ltd.

The site occupies a former garage and will form a strong urban street frontage to Victoria Road with a more relaxed suburban feel.

The completed development will provide 39 Houses and Cottage Flats for Social Rent, including amenity and wheelchair friendly properties and 24 Apartments for Mid Market Rent. The Social Rent properties will be let by Kingdom Housing Association from the Fife Housing Register and the Mid Market Rent properties will be let though Kingdom Initiatives which is a wholly owned subsidiary of Kingdom Housing Association.

The Mid Market Rent apartments will be available from November 2017 (est.) and the Social Rent properties will be available in several phases from February 2018 (est.) to late 2018 / early 2019.

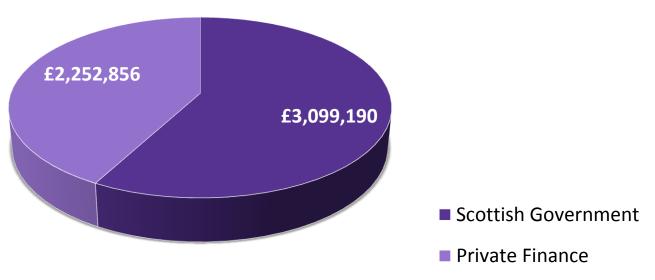

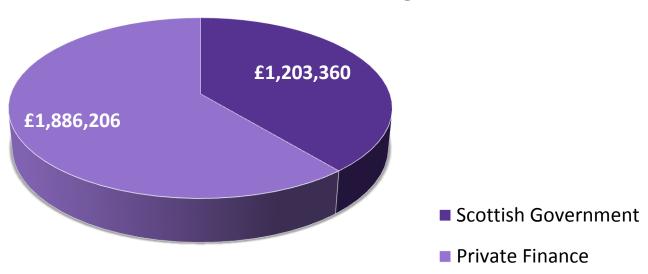
