# **Shared Ownership Resales Application Form**

#### What is Shared Ownership and how does it operate?

Shared Ownership is a form of low cost home ownership that combines renting with buying. It is aimed at people who want to buy their own home but presently cannot afford to buy outright. The purchaser owns a share of the property and rents the remaining part from us through an occupancy charge. The Shared Ownership Agreement (also known as an Exclusive Occupancy Agreement) that you enter into is for a 20 year period. You will be contacted well in advance of that date to agree on an appropriate way forward.

# Who is Shared Ownership for?

We cannot consider you for shared ownership if you:

- Plan to buy in order to sublet
- Do not intend to live in the property and use it as your only and principal home
- Can afford to buy a property outright

## Priority will be given to:

- First time buyers with limited housing alternatives
- Members of the Armed Forces
- Veterans who have left the Armed Forces within the past two years
- Widows/widowers/other partners of service personnel for up to two years after their partner was killed while serving
- Public sector tenants
- Families on low incomes
- Disabled People

# What percentage of a home can I have?

You will need to purchase the share being sold by the current sharing owner or you can buy 100% (with our and the seller's consent).

You have the option to buy additional shares anytime after the first anniversary of your date of entry; however, any additional shares will be based on the current market value at that time. This is often known as 'staircasing'. When you purchase an additional share in your property, the Occupancy payment to us will be recalculated to reflect the reduction in our share.

# What responsibilities does a sharing owner have?

Like other owners, you will be responsible for the full cost of any internal and external repairs, maintenance, factoring costs, legal fees, stamp duty and any other household costs such as:

- Mortgage repayments
- Occupancy charge
- Factoring costs
- Buildings & contents insurance
- All repairs and maintenance to your property
- Council Tax to your Local Authority
- Heating, Lighting, and Water Bills
- Fittings and Furniture (i.e. you will responsible for supplying your own fittings and furniture for your home)

You will need to take these costs into account when assessing whether you can afford to buy a property. You should seek independent financial and legal advice on the responsibilities that come with being a home owner, both generally and in relation to any particular property you select.

#### What do I do if I am interested?

- Complete this form so we can assess if you are eligible for shared ownership.
- If you are eligible, you can view the property and make a verbal offer if you decide to do so.
- If your verbal offer is accepted, follow this up with a written offer with your solicitor and agree a proposed date of entry.
- The solicitors will liaise with each other to progress matters.
